The rates quoted should be for delivery of the articles at the place mentioned below the schedule. The necessary subscription of the date for the receipt of quotations, the date up to which the rates will have to remain from for acceptance and the name and address of the officer to whom have to remain from acceptance and the name and address of the officer to whom have quotations is to be sent are noted below. Any quotations received after the time fixed on the due date is liable to be rejected. The maximum period required for delivery of the article should also be mentioned. Quotations not stipulating period of firmness and with price variation clause and / or

subject to prior sale condition are liable to be rejected.

The acceptance of the quotations will be subject to the following conditions:

- 1. Acceptance of the quotation constitutes a concluded contract. Nevertheless, the successful renderer must within a fortnight / a month after the acceptance of his quotation furnish 5 per cent of the amount of the contract as security deposit and execute an agreement at his own cost for the satisfactory fulfillment of the contract. If so required.
- 2. Withdrawal from the quotation after it is accepted or failure to supply within a specified time or according to specifications will entail cancellation of the order and purchases being made at the offerer's expenses from elsewhere, any loss incurred thereby being payable by the defaulting party. In such an event the Government reserves also the right to remove the defaulter's name from the list of Government suppliers permanently or for a specified number of years.
- 3. Samples, duly listed, should be forwarded if called for under separate cover and the unapproved samples got back as possible by the offered sat their own expenses and the

government will in no case be liable for any expenses on account of the samples or their transport charges etc. In case the samples are sent by railway receipt should be sent separately, and not along with the quotation since the quotation will be opened only on the appointed day and demurrage will have to be paid if the railway parcels are not cleared in time. Quotations for the supply of materials are liable to be rejected unless samples, if called for of the materials tendered for are forward. The approved samples may not be returned at the description of the undersigned. Samples sent by V.P. post or 'freight to pay will not be accepted.

- 4. No representation for enhancement or price /once accepted will be will be considered during the currency of the contract.
- 5. Any attempt on the part of renderers or their agents to influence the officers concerned in their favor by personal canvassing will disqualify the renderers.
- 6. If any licensee or permit is required, renderers must specify in their quotation and also state the authority to which application is to be made.
- 7. The quotation may be for the entire or part supplies. But the renderers should be prepared to carry out such portion of the included in their quotation as may be allotted to them.
- 8.a) In cases where a successful tendered, after having made partial supplies fails to fulfill contracts in full, all or any the materials not supplied may, at the discretion of the purchasing officer be purchased by means of another tender / quotation or by negotiation or from the next higher tendered who had offered to supply already and the loss ,if any, caused to the government shall thereby together with such sums as may be fixed by the government towards damages be recovered from the defaulting tendered.
 - b) Even in case where no alternate purchases are arranged for the materials not supplied, the proportionate portion of the security deposit based on the cost of the materials not supplied at the rate shown in the tender of the defaulter shall be forfeited and balance alone shall be refunded.
 - c) Any sum of money due and payable to the contractor (including security deposit returnable to him) under this contract may be appropriated by the purchasing officer or government or any other person authorized by government and set-off against any claim of the purchasing officer or government for the payment of a sum of money arising out of or under any other contractor with the purchasing officer or government or any other person authorized by government.
- 9. The prices quoted should be inclusive of all taxes, duties, cases, etc. Which are or may become payable by the contractor under existing or future laws or rules of the country of origin / supply or delivery during the course of execution of the contract.
- 10. Ordinary payment will be made only after the supplies are actually verified and taken to stock, but in exceptional cases, payment against satisfactory shipping documents including certificates of insurance will be made up to 90 percent of the value of the material at the discretion of government. Bank charges incurred in connection with payment against documents through bank will be to the account of the contractor. The firms will produce

stamped prereceipted invoices in all cases where payments (advance /final) for release of railway receipts / shipping documents are made through banks. In exceptional case where stamped receipt of the firms is not received for the payments(in advance)the unstamped receipt of the bank (i.e., counter foils of pay-in –slip issued by bank)alone may be accepted as a valid proof for the payment made.

b) The renderers shall quote also the percentage of rebate (discount) offered by them in case the payment is made promptly within fifteen days / within one month of taking delivery of stores.

- 11. Any sum of money due and payable to the successful renderer or contractor from government shall be adjusted against any sum of money due to government from him under any other contracts.
- 12. Special conditions, if any, printed on the quotation sheets of the renderer or attached with the tender will not be applicable to the contract unless they are expressly accepted in writing by the purchaser.
