## **Minutes of the Meeting:**

- 1. The meeting reviewed and approved the minutes of the 76<sup>th</sup> BOG meeting held on March 25, 2022. Discussions ensued on the activities in the institute post the last BOG meeting, including curricular and co-curricular events in all six departments. Placement data for various departments were also deliberated upon, with the meeting expressing satisfaction with the performance of the departments during the academic year 2022-23.
- 2. The results of the diploma examination held in April 2020, 2021, and 2022 were presented. The institution's performance during these years was deemed satisfactory, and detailed statistics were outlined on page 65 of the annual report.
- 3. Budget estimates for the institution and the continuing education cell for the year 2023-24 were presented and discussed. Details are available in pages 66-75 of the annual report. The meeting approved and passed the budgets for both the institution and the CE cell.
- 4. The meeting ratified all seven appointments made since the last BOG meeting, including three lecturers, one office attender, one tradesman, one physical education instructor, and one librarian. Details can be found on page 76 of the annual report.
- 5. Since the last BOG meeting, there were eight promotions to higher posts, two conversions from temporary to permanent posts, four declarations of promotions, and five higher grade promotions. Details have been outlined in the report from page 76 to page 79 of the annual report. The meeting ratified all these promotions.
- 6. The meeting was informed that Mrs. Raina TH, Tradesman, applied for LWA for study purposes. However, her application is still pending with the government.
- 7. Mr. Mohammed Ibrahim CP, Lecturer, and Mr. Abdul Rasheed, Tradesman, have been removed from service. However, the removal is yet to be ratified by the government.

8. The meeting approved and passed the audited account statements of the institution and CE cell for the year 2021-22. Details are available on pages 81-123 of the annual report.
